HSCA NAMES SUPPLY CHAIN VETERAN TODD EBERT AS PRESIDENT AND CEO

Executive With More Than 40 Years of Healthcare Expertise to Be Chief Advocate for the Healthcare Supply Chain Industry Amid Ongoing COVID-19 Response Efforts

Prior to HSCA, Ebert joined Amerinet (now Intalere) in 1992 and subsequently served in a variety of leadership roles, including vice president of Amerinet's pharmacy program, president of Amerinet's private-label company, and president and COO. He took over as president and CEO in 2007 and served in that capacity until 2015. A registered pharmacist, Ebert has gained extensive experience across various sectors of the healthcare industry. He is a former vice president and general manager of a specialty healthcare product logistics company; a director of hospital and retail pharmacy; and he has owned and operated a nursing home clinical pharmaceutical consulting company.
